

Monday, March 27, 2023 (day 78 of the 120-day session)

This past week saw a full schedule of committee meetings as the legislature navigates the bills that are still standing. We also saw the release of the first operating budget proposal from the legislature on Thursday afternoon, which came on the heels of our state's latest revenue forecast. What's more, the State Supreme Court issued its ruling on the Capital Gains tax, which came down this Friday morning. Read on to discover how these three things go together.

#### **Revenue Forecast**

- ➤ Increase of \$194 Million for the 2021-2023 Biennium
- Decrease of \$483 Million for 2023-2025 Biennium
- Decrease of \$541 Million for 2025-2027 Biennium

#### **Supreme Court Ruling on Capital Gains**

On Friday morning our state supreme court issued a ruling on the constitutionality of a tax on capital gains income as it relates to our state's prohibition on income taxes. The court ruled with the legislature and upheld the Capital Gains tax in its current form. The significance of this is the Senate budget proposal relies on \$500 million from this revenue vehicle in 2023-2025 to balance the four-year outlook.

While we haven't had the ability to go through the entire 1200+ pages of the \$70 billion operating budget, we can report some of the highlights:

## **Operating Budget**

- ➤ Balances on a four-year outlook with no new or increased taxes
- ➤ Assumes \$500 Million in revenue from Capital Gains Tax
- Uses \$200 Million in leftover Covid relief dollars.
- ➤ \$480,000 for agriculture stakeholders to participate in a process facilitated by an independent entity to develop recommendations on proposed changes in policy and spending priorities to improve riparian habitat to ensure salmon and steelhead recovery.

- ➤ \$2,256,000 to provide technical assistance to landowners to promote voluntary compliance, implement best management practices and assistance focused on protection and restoration of critical riparian management areas important for salmon recovery.
- ➤ \$4,424,000 of the general fund—provided solely for local food system infrastructure and market access grants.
- ▶ \$4 Million of covid relief dollars for grants to school districts to expand career and technical education graduation pathway options, including career-connected learning opportunities.
- Public Schools get largest slice of budget, \$30.7 Billion.
  10.5% increase in K-12 Spending over and above the 2021-2023 biennium levels.

While this budget proposal came from the Senate Democratic Caucus, it has already received praise from Republican leaders across the aisle to show bipartisan support of the funding initiatives. Senate Republican Ways & Means ranking member Lynda Wilson said this budget is the "most inclusive budget proposal we have seen in years".

This is only the first budget proposal of the session from the legislature. <u>House Democrats will release</u> their operating budget proposal on Monday March 27<sup>th</sup> at 12:00pm.

## **Riparian Grant Program**

HB 1720 - The Riparian grant program bill has been one of the biggest issues for the agriculture community this session. The agriculture community, with several of our Washington State tribal nations, worked tirelessly over the interim to develop a voluntarily stewardship program around ecosystem habitat through riparian area improvements. The bill was supported by both sides of the isle and had both Democrat and Republican sponsors. The bill has failed to clear a critical cutoff and remains dormant in the House Capital Budget committee. The Governor's office opposed this bill from the beginning and worked on the inside to stop the bill from getting through the first half of the session.

Bill sponsors are working together to make this grant program a part of the Capital Budget. Tell your legislators to support this in the Capital Budget.

#### **Agriculture Overtime**

SB 5476 -Authorizing agricultural employers to select 12 weeks a year to employ workers for up to 50 hours a week before overtime applies. This bill has failed, and the current structure will remain that overtime hours must be paid after:

- -55 Hours in 2022
- -48 Hours in 2023
- -40 Hours in 2024

#### **Pesticides**

SB 5330 - Washington Pesticide Application Act Authorizes WSDA to conduct rulemaking to require noncertified applicators, working under the supervision of a certified applicator. Increases the minimum age of all licensees to 18 years of age.

HB 1019 - Creating the pesticide advisory board. Creates an 11-member pesticide advisory committee with dedicated seats for industry stakeholders.

SB 5143 - Changing the name and membership of the commission on pesticide registration. Changes the name of the Commission on Pesticide Registration to the Commission on Integrated Pest Management. Adds a rep of the U.S. EPA as a nonvoting member of the Commission.

#### **Voluntary Stewardship**

SB 5353 – Voluntary Stewardship Program

Opens the Voluntary Stewardship Program up to remaining counties who did not enter by 2012. Allows remaining counties to enter the program with no closing date. This bill is moving along and please let your legislature know that is has our support.

# **Drought Preparedness**

HB 1138 – Concerning Drought Preparedness

- Provides that projects funded by grants issued to address drought conditions no longer need to be completed while a drought emergency order is in effect.
- Creates the Emergency Drought Response Account in the State Treasury.
- Modifies the circumstances in which the Joint Legislative Committee on Water Supply During Drought is authorized to convene, to include when a drought advisory is in effect and when a drought emergency order is in effect.

This bill has cleared the policy committee and is heading to Senate Ways & Means.

#### **Odometer Readings**

HB 1736 - Requiring the department of licensing to collect vehicle odometer readings at the time of original vehicle registration and registration renewal. This bill still has legs as it cleared the first House of Origin cutoff and is scheduled for a vote on Monday March 27<sup>th</sup> in Transportation committee.
