Gov. Inslee Releases 2019-2021 Proposed WA State Budget

Governor Inslee released his proposed budget for the 2019-2021 biennium in mid-December. His proposal serves as a starting point for the legislature. The legislature may add to, delete or modify anything in the Governor's proposal. The budget is one of the last things the legislature acts on, so the final version will be available just before the legislature adjourns next spring.

Governor Before the prepares his budget, each state agency submits a budget request outlining what they want for each program they manage. Digging into the details of the budget, human service agencies and public schools got more funding than they requested. Natural resource programs took the biggest hit, with one exception. The Washington Wildlife and Recreation Program got an historic \$115 million in funding in the Governor's budget. On the other hand, the Conservation Commission had requested new funding for a variety of programs, they got almost none of it. There were a few small, but bright spots for agriculture. The department of agriculture got \$500,000 to expand their pesticide safety education program and funding for the new soil health initiative. The soil health initiative will be a joint program led by WSU. The



to increase spending by \$10 billion over the next two years. That is a 22% increase in state spending. \$4.1 billion of the increase is to cover the ongoing cost of complying with the Washington Supreme Court in the McCleary school funding lawsuit. The budget also creates several new programs including prioritizing mental health, orca recovery and studying the removal of dams along the Snake River.

New programs take money, so Governor Inslee proposes creating a new state capital gains tax of 9% and increasing the business and occupation tax on professional services by 67%. These proposed tax increases would bring in an estimated \$3.7 billion over the next two-years. Capital gains from the sale of homes, farms and forestland would be exempt from the new tax, however, the exemptions are narrow. While farmland would be exempt, the sale of barns, sheds, equipment areas and the land under them would be taxed.

Inslee also proposes converting Washington's flat real estate excise rate to a graduated rate to pay for the court-ordered removal of barriers to fish passage. That means, the higher the sales price on the property, the higher the tax rate.

These new taxes are being proposed at a time when revenue collections from existing taxes have been increasing due to a strong economy. Washington is projected to have more than \$3.2 billion in reserves at the end of the current two-year budget cycle.

Creative Writing – Options for Everyone

Your state Lecturer Team met at the headquarters building on December 16th to develop department program our for 2019. Although we were missing two of our members, we managed to review this last year's elements and have made some changes. The two areas with the most changes were in the Talent Contest and the Creative Writing programs. I will address the Talent Contest changes in a future column. Because the Creative Writing Contest is the first activity on our calendar, I will share those changes with you this month.

Poetry – The 2019 theme for the Poetry Contest is: Cowboys and/or Cowgirls. Your poem can be about a cowboy or a cowgirl or both. We have eliminated the word limit.

Short Story – The short story theme for 2019 is "It Happened At The Fair." This category has a maximum word limit of 500 words. Remember, your short story should entertain the reader.

Essay - The 2019 theme for the essay is "Good Things That Happen In The Grange." This category also has a 500 word limit. Your essay should be informative for the reader.

Book Review - This is a review of a book that you would recommend to others. Your entry should evaluate/ critique the overall work - not re-tell the story of the book. The word count has been eliminated.

The divisions are: Adults, age



20 and older and Youth, ages 14 – 19. There is no contest for kids younger than 14. The complete WA rules for the Creative Writing Contest will be in the Program Handbook, on the website and in the Lecturer Packet at the Leadership Conferences.

Ag In The Classroom

Increasing Ag Literacy Of K-12 Students - One Classroom At A Time

Did You Know?

The State of Washington leads our Nation in the production of these crops (2017 crop data):


Aquaculture (clams and oysters), Red Raspberries, Blueberries, Concord Grapes, Pears, Sweet Cherries, Apples, Wrinkled Seed Peas, Green Peas, Spearmint Oil, Hops.

There is a part of the hop plant that can be used in bee hives to remove destructive mites?

After experimentation and testing, the proper level of HBAs (hop beta acids) was determined to effectively destroy the mites while keeping the bee colony safe. Scientists extract the HBA from the cones of hop plants, apply it to cardboard strips, and then insert the strips into colony hives. Bees walk on these strips, picking up the HBAs, and transfer it through bee-to-bee contact. The mites on these bees are then killed and fall off. This method does not completely decimate the varroa mite population, but it can keep the mite levels below dangerous levels.

We are pleased to help students, parents, and educators learn more about our Washington agriculture. How?

The first of our three Ag@School magazines was mailed in October to 10,000 Washington students. This issue highlights the diversity of Washington agriculture with articles such as "Agriculture – From Field to Table", "Agriculture is Science and Technology", "Grown in Washington", "Hooray-



Who!. Volunteer readers and students are excited about this new book. Another great book from "Readers to Eaters" is Bread Lab!. Check them out! Volunteer readers are being recruited now to begin in February.



Well done, good and faithful servant. In Memoriam ... Past State Grange Deputy Gordon Peterson

Gordon C. Peterson passed away on Oct. 5, 2018 at Marlin, WA. He was born on Nov. 3, 1929 to Erna and Pete Peterson in Spokane, WA and was an only child. He was raised on the three generation family cattle and wheat farm.

At Marlin, he attended a one room school and graduated as a valedictorian from Marlin High School. He graduated from



Whitworth College, Phi Beta Kappa, with a degree in education and minor in economics.

His first job was teaching Social Studies in Harrington. The rest of his career he taught middle school and then moved to the high school in Coulee City Schools. He taught Social Studies, English, Latin and Journalism. In addition, he was Senior Class Advisor, directed school plays and supervised the Senior Educational Trip. Many of his students remember learning and reciting his "infamous" poems and writing term papers. In his English classes he provided a strong foundation in vocabulary, sentence structure and writing. Outside of school, he continued his contact with students in various ways. Many remember him keeping the score books for boys and girls basketball games.

In addition, he served on the Coulee City School Board, was a member of the Coulee City Council and Coulee City Rodeo Association. He was very active with local Boy Scout Troop 35 and helped with many Eagle Scouts. His diligence with Boy Scouts at the many levels earned him the Boy Scout Silver Beaver Award. In addition, he was a member of the Cannaiwai Grange, Lincoln County Pomona Grange and Parliamentarian at the State Grange.

When he retired, he moved back to his farm in Marlin where he enjoyed his beloved Herefords, cats and dogs. Gordon had hired men to help with the cows, irrigation and hay.

Throughout his life he was a devout Lutheran and member of the Salem Lutheran Church in Marlin. He leaves many past students, teachers, administrators, neighbors and friends.

Enjoy Winter With Spiced Pumpkin Bars

Start your favorite movie and warm up your chilly day with a cozy blanket, a mug of hot chocolate and a plate of some of these incredible Spiced Pumpkin Bars. Recipe adapted from Better Homes and Gardens via Culinary.net.

Spiced Pumpkin Bars

2 cups flour 2 tsp baking powder 2 tsp ground cinnamon 1 tsp baking soda 1/4 tsp salt 4 eggs 15 oz can of pumpkin 1 2/3 cups sugar 1 cup cooking oil 1 tsp vanilla 3/4 cup chopped pecans (optional) 8 ounce package cream cheese, softened 1/4 cup butter, softened 2 cups powdered sugar (sifted) Pecan halves (optional)

1. In a medium bowl stir together flour, baking powder, cinnamon, baking soda, and salt; set aside.

2. In a large mixing bowl beat together eggs, pumpkin, sugar, and oil on medium speed. Add the flour mixture; beat until well combined. If desired, stir in chopped pecans.

3. Spread batter into an ungreased 15x10x1-inch baking pan.

4. Bake in a 350° F oven for 25 to 30 minutes or until the center comes out clean. Cool completely in pan on a wire rack.

5. In a medium mixing bowl beat together cream cheese, butter, and vanilla until fluffy. Gradually add sifted powdered sugar, beating until smooth.

6. Frost pumpkin bars. If desired, top with pecan halves. Cut into squares. Store, covered, in refrigerator up to 3 days.




The 2019 National Grange Quilt Block is called Pride of Quillisascut which is based on the Disappearing Nine Patch, also called Split Nine Patch. The Pride of Quillisascut came to be as the result of me challenging Joan Roberson, the 2017 contest winner, and her fellow Quillisascut Quilters of Quillisascut Grange #372 in rural, northeast Washington state to select the block for the 2019 contest. fabrics.


Fabric A should be a medium to dark print.

Fabric B should be significantly lighter than Fabric A.

Fabric C should be <u>BRIGHT</u>! Not a pastel bright, but a strong <u>BRIGHT</u>!

All fabric used should be cotton.

I can't wait for these big, bold blocks to start appearing in my mailbox. I hope you enjoy putting one, or many, together!

2019 Quilt Block Contest Pride of Quillisascut

(based on the Disappearing Nine Patch, also called Split Nine Patch)

Fabric:

Three Fabrics. The key to this block is that there is good contrast between all three Constructing the Quilt Block:

- Cut all pieces to 4-1/2 inch x 4-1/2 inch square.
- Fabric A: Cut four.
- Fabric B: Cut four.
- Fabric C: Cut one.

Use a 1/4 inch seam allowance. Sew into three rows: ABA, BCB, ABA. Sew the rows together into a single block.

Cut the block into four equal pieces through the middle. Rotate two blocks. Clip and remove all threads. Press all seams. Sew the block back together. Unfinished block should measure 12-1/2 inches x 12-1/2 inches.

Clip and remove all threads.

Note: Special recognition and thanks to the Quillisascut Quilters of Quillisascut Grange #372 in rural, northeast Washington state for taking on the challenge of selecting the block for the 2019 National Grange Quilt Block Contest by virtue of one of the members, Joan Roberson, winning the 2017 contest. Fantastic work!

2019 Quilt Block Contest Rules

Rules:

A. The National Grange Quilt Block Contest is open to everyone. B. All contest entries must be received by the National Grange Lecturer by October 31, 2019. Send entries to: Christine Hamp, National Lecturer, 16418 North Birdie Road, Nine Mile Falls, WA 99026.

C. Any entires received after the deadline will not be judged. However, all entries received will be exhibited at the 153rd National Grange Convention in Minneapolis, Minnesota.

D. The quilt block you enter in the contest must be made by you.

E. There is no limit on the number of quilt blocks a person may submit, but choose one quilt block per person to be judged. F. All entries will be retained by the National Grange to be made into finished quilts and other items to be sold at a later date to raise funds for the Grange Foundation, a 501(c)(3)non-profit entity.

G. A 2019 Quilt Block Contest Entry Form must be completed for the block to be judged.

Lummi Island: A Grange Success Story

In 2017, the Lummi Island Grange #925 received a requested safety inspection from the Whatcom County Fire Marshall. This inspection pointed out several safety issues which needed to be addressed for the continued safe use of the Grange building by community members. Several of the minor findings were able to be resolved by our Grange Maintenance Team, however, major egress issues were identified, which reduced our legal occupancy of our main hall to only 49 persons. This had a major effect on the community's ability to use the hall as a meeting place, as it had for nearly 80 years. A building improvement committee was formed at a Grange meeting, and plans were started for finding a way to address the egress issues. A local island architect volunteered to inspect the asbuilt conditions, and produce



drawings and blueprints for necessary structural modification to the building. A local building contractor volunteered his time and efforts to work with a team of other volunteers, to complete required construction the work. Individual members of the community, and island organizations, donated over \$6,000, for the necessary building materials. Whatcom County Public Works issued a building permit for the construction to begin. By October, 2018, all construction was completed. A new set of French Doors were installed on the West side of the main hall, leading out to a large deck. Installation of the doors required modifying the building roof with a gable, to allow full



height doors where the roof had been too low to permit. A new front landing and stairs were constructed to permit rapid exit from the existing doors on the East side of the hall. In November, 2018, Whatcom County Public works conducted the final building inspection, and approved all modifications. The Whatcom County Fire Marshall was invited to come and re-inspect the building, and he then assigned an A-2 building code, and raised the occupancy permitted to 99 persons. Once again, the Lummi Island Grange is able to serve the community's needs for public events, thanks to the many generous neighbors who share our small island.
