



Granges Compete At The Washington State Fair

In a fierce competition, Humptulips Grange #730 and Waller Road Grange #1111 shared the first place awards for Grange displays at the 2024 Washington

State Fair. Humptulips was the Grand Champion for the "arrangement" category, while Waller Road was the Grand Champion for overall Grange display. Ten Granges created displays for this year's fair. The displays are judged on a wide range of criteria. The arrangement of the display is based upon the design, originality, artistic effect, arrangement of fresh and preserved produce, and overall impact. Each of the six judges scores the displays, with

special emphasis from two judges with an artistic background. Humptulips was awarded first

President's Message

Wrapping Up 2024; Opening The Book On 2025

We've certainly had an eventful summer of Grange activities!

The 134th Annual State Session was held in June at the Northeast Washington Fairgrounds in Colville. We acted on 43 resolutions and eight Standing Committee Reports. There were several new faces in the voting delegates. We elected two new state officers and conferred the Sixth Degree on 46 candidates. The Granges of the Eastern District (Adams, Asotin, Benton, Columbia, Franklin, Garfield, Lincoln, Pend Orielle, Spokane, Stevens, Walla Walla, Whitman) did an excellent job of hosting the session. The proceedings for the session are now available on the front page of the State Grange website: www.wa-grange.com. Due to delegate action, we will not be printing and sending the proceedings out to each Grange. This change will allow you to have access to the proceedings and to print out the pages you need/desire at your convenience.

The Junior Grange Camping Program made a full return this summer. From Camp Wooten in the Southeast corner of the state to Camp David on the shores of Lake Crescent, and Camp Mayfield in Southwest Washington, we were able to provide three weeks of camping activities for Junior Grangers across the state. Due to camp facility issues, Camp Morehead held three days of Day Camp. Camp NEWA and Camp Cornet Bay did not hold camps this year. All six camps are planning to operate in 2025. Pictures from each of the camps can be found elsewhere in this issue. The number of campers is increasing to our pre-Covid days. Each Grange should start looking now to identify kids to attend our camps in 2025.

We recently completed the third year of the Grange Youth Fairs Program in our state. We increased our participation to 16 fairs this year. We are still compiling numbers of participants and entries for this year. Thank you to the following fairs for allowing our Grange Youth and Juniors to participate: Clark County Fair (Ridgefield), Grays Harbor County Fair (Elma), Clallam County Junior Livestock Auction (Sequim), Kittitas County Fair (Ellensburg), Grant County

We will gather for a group photo of our state's representatives on Saturday evening after the Celebration Banquet.

Washington State has two Distinguished Granges this year –Five Mile Prairie and Goldendale. More than 100 Granges from our state will be recognized as Granges in Action. Entries have also been submitted for the Junior Grange and Community Service Departments. Our state also had entries in the Lecturer and Junior Grange Department Contests. Election Info, Harvest Report, And More...

Happy Autumn! The leaves have started to turn which tells political junkies like me that it's just about time to start handicapping races and counting ballots. We are just about a week away from seeing ballots in the mailbox to kick off Washington State's long voting session. In Washington we have a voting window of over two weeks that allows citizens to deliberate and get their postmarks done by November 5th. See below for remaining election deadlines:

October 18- Start of 18-day voting period (through Election Day). Ballots are mailed out and Accessible Voting Units (AVUs) are available at voting centers.

October 28- Online and mail registrations must be received 8 days before Election Day. Register to vote in person during business hours and any time before 8:00 p.m. on Election Day.

November 5 - Deadline for Washington State voter registration or updates (in person only).

November 5 - General Election - Deposit your ballot in an official drop box by 8 p.m. on Election Day.

Voter Registration Requirements:

In Washington State you do not need to show ID or proof of citizenship to cast a vote for Washington State candidates. Our state allows for numerous other forms in order to obtain a voter registration including bank statements, utility bills, paychecks, tribal ID and other forms. Harvest Report!

Washington continues to lead the nation in apple production, and this year's harvest has set records. Favorable weather conditions specifically a warm spring followed by timely rainfall—contributed to a bumper crop. Early estimates suggest that apple yields are up approximately 15% compared to 2023. Varieties such as Honeycrisp, Gala, and Fuji are particularly high in yield, with growers reporting high quality fruit making them highly sought after in both domestic and international markets.

The cherry harvest also enjoyed a successful season in 2024. Washington's cherries are known for their quality, and this year was no exception. Growers reported a yield increase of around 10% compared to last year, aided by ideal growing conditions. The early season cherries, particularly sweet varieties like Bing and Rainier, benefited from warm weather, resulting in a great.

Both the apple and cherry markets have finally seen increased demand, which is promising for farmers. With harvests exceeding expectations, exporters are preparing to meet international demand, particularly from markets in Asia and Europe. The quality of the fruit has also attracted attention, positioning Washington's apples and cherries as premium products in the global market.

The 2024 wheat harvest in Washington State has been positive as well, with farmers across Washington reporting solid yields for both soft white wheat and hard red varietes. Preliminary estimates indicate that the state's wheat production has increased by around 12% compared to 2023. Ideal growing conditions—aided by timely rainfall and moderate temperatures—contributed significantly to the strong crop. In addition to high yields, the quality of this year's wheat has been above average. Grain samples have shown strong protein levels and low moisture content, making the wheat particularly attractive for both domestic milling and international export markets. Look for farmers to store grain through the winter until prices have risen to desirable levels.

place for their arrangement, followed by Thurston County Pomona Grange in second place, Fruitland Grange in third place, Waller Road Grange in fourth place, and Ohop Grange in fifth place. The arrangement score factors in as 20% of the total display score.

The items included in the display contribute the other 80% of the overall score. Agricultural products include grains and seeds is worth 20%, while livestock products (meats, dairy, poultry, honey, shellfish, etc.) contribute an additional 20%.

Horticultural products include

fruits, berries, nursery stock, plants, forest products, and herbs. This section contributes 20%, while the vegetable category contributes the final 20%. Each display is required to have 50 items in each of the four categories.

Four judges, one for each category, scores their category based up quantity, variety, and quality. After judging is completed, fair officials tally the scores to determine the overall winners. Waller Road Grange was the first place overall winner, followed by Humptulips Grange in second place, Collins Grange in third place, Thurston County Pomona Grange in fourth place, and Meridian Grange in fifth place.

Other participating Granges in 2024 were Elk Plain, East Hill, and Black Lake.

Each of the ten exhibiting Grange spend hundreds, and possibly even thousands, of hours of work on their Grange displays at the Washington State Fair in Puyallup. Each starts out with the same dimensions, approximately 8 feet wide and 10 feet deep. The slope of the displays is predetermined and remains the same each year. Grange members spend months creating designs, canning and dehydrating fresh produce, collecting seeds and cones, and

gathering display items from their Grange members, neighbors, and friends.

Each Grange is responsible for their own design and builds a framework with their design prior to arriving at the fair. The Grange display building in Puyallup is usually ready for the Granges to start setting up one week prior to the fair. Most Granges will get their framework set up and the basic design in place 4-5 days before the fair. The last few days are spent gathering the fresh produce items and placing them into the display. It is a push to the finish to get everything into the display and have it arranged in an attractive manner.

The Washington State Fair, formerly known as the Western Washington Fair and the Puyallup Fair, was first held in 1900. Grange displays have been a part of the fair since its inception.

State Grange Delegates Make Recommendations On Ballot Initiatives

The delegates to the 135h Annual State Grange Session reviewed current Grange policy and then made the following recommendations for initiatives on the ballot in the November 2024 General Election:

▶ Initiative 2109 – Repeal the Capital Gains Tax – the delegates encourage a YES vote on this initiative.



▶ Initiative 2117 – Prohibit Carbon Tax Credit Trading and Repeal Carbon Cap-and-Trade Program - the delegates encourage a YES vote on this initiative.

► Initiative 2124 – Opt Out of State-Run Long Term Care Coverage Act - the delegates encourage a YES vote on this initiative.

Fair Booth Contest – The Last Lecturer's Department Contest For 2024

2024 GRANGE FAIR BOOTH CONTEST

The objective of the fair booth program is to improve public opinion of the Grange and the community it serves by telling the story of agriculture. Rules for the contest are as follows:

1. Entries are due to the State Lecturer, postmarked by October 31.

2. The entry shall consist of a report (400 words maximum) describing the display and shall be accompanied by photographs and/or newspaper clippings. All photos and clippings shall be attached to a piece of paper/cardstock - in other words... no lose clippings or photos. Clear, concise photos are important since the judges cannot see the actual booth. The report shall be no more than 8 total pages. The entry must be in a folder of some type (No hard cover binders.) Judging will be done by three qualified judges.

3. The front page of the

report shall include the following information: Grange name and number, name of the fair entered, contact person's name and mailing address, and division entered.

4. Subordinate Granges: There will be two divisions: Division I - Produce; and Division II - Project. Each subordinate Grange putting a display in any fair are eligible to enter the contest. Granges participating in multiple fairs may have multiple entries. Prizes in each division are sponsored by the Washington State Grange and will be: First Place - \$100; Second Place - \$75 and Third Place - \$50.

5. Pomona Granges: There will be two divisions: Division I - Produce; and Division II -Project (either agricultural, educational, or informational). Each Pomona Grange putting a display in any fair is eligible to enter the contest. Pomona Granges participating in multiple fairs may have multiple entries. Prizes in each division will be: First Place -\$100; Second Place - \$75 and Third Place - \$50. 6. Grange Youth Groups: Grange Youth (ages 14-35) Groups creating a display and entering it in the name of the youth group at any fair are eligible for this class in the state contest. All displays will be judged in one division using the Project Division Score sheet. Prizes, sponsored by the Washington State Grange, are: First Place - \$50; Second Place \$30; and Third Place - \$20.
7. Judging criteria in the Produce Division: Booth Arrangement and Design -200 points; Livestock Products (quality, quantity, and variety)
200 points; Agricultural Products/Seeds/Grains (quality, quantity, and variety)
200 points; Horticultural Products (quality, quantity, and variety of herbs, forest products, fruits, nursery stock, flowers, etc.) - 200 points; and Vegetables (quantity, quality, and variety) - 200 points; total of 1000 possible points.

8. Judging criteria in the Project Division: Choice of Message -20 points; Supporting Data - 30 points; Visualization of Message/ Design of Display - 30 points; and Originality - 20 points; total of 100 possible points.



Melissa Kudsk To Represent Washington State Youth At National Grange Convention



Melissa will travel to the National Grange Convention in Bettendorf, IA. She will participate in the various youth activities and will interview with a panel of judges.



Junior Grange Camps Grow For The Future

The Washington State Grange Junior Camping Program experienced an increase in participation in 2024. Three summer resident camps were held in 2024, with one, Camp Morehead sitching to a day camp due to last minute facility issues. All camps reported successful programs as they work to rebuild programs to the levels of the pre-covid era.

The Grange operates six weeks of summer camp around the state as a part of their programming for kids, ages 8-14. While each of the camps operates independently and under the guidance of a board of directors, the Washington State Grange retains jurisdiction and the ultimate responsibility of the camping program.

The daily program varies from camp to camp. Each of the camps does participate in the traditional Grange opening, closing, and Junior Grange degree. Craft projects range from nature craft and jewelry making to sewing and tie dye creations. The recreational activities of each camp depend upon what is available in that area.... be it hiking, swimming, archery, fishing, dancing, and games. Educational features included making pickles, food dehydration, and outside speakers on a wide variety of topics.

Plans for the 2025 Junior Grange Camping Program are now underway. Camp registration information will be available in January. While we held four camps this year, Camp Cornet Bay in Northwest Washington is planning to operate in 2025, along with possibly Camp NEWA in Northeast Washington.

A View From The Hill - Fall 2024 Wrap-Up

AGRICULTURE AND FOOD

Last-ditch appeal for a farm bill now

Farmers hammered hardest by commodity market declines hit Capitol Hill in early September for a final push to get a new farm bill this year. In an unusual lobbying strategy, teams of farmers representing the row crops that depend upon the major commodity title programs were accompanied by ag lenders who made the case that many of these farmers will face a dire financial situation because of price declines heading into the next year. But time is fast running out to pass a new farm bill. The Senate Agriculture Committee has taken no action, and the House Agriculture Committee farm bill has a \$33 billion funding gap. Congress will likely pass a oneyear extension in the lame-duck session after elections.

Reality check on food price policy

A majority of consumers in both political parties apparently believe elected officials of either party can help lower grocery prices given how important inflation is to likely voters this fall. Despite what both Vice President Harris and former President Trump are promising on the campaign trail, the next leader of the free world has limited options to lower food costs in a speedy or widespread manner. However, the next President might try using the bully pulpit, increasing antitrust enforcement, enforcing a price-gouging ban, and, many economists argue, expanding the domestic energy supply.

Food aid shortages cause concern

HEALTH CARE

Rural maternal health is a growing concern

A lack of access to obstetric care in rural areas is a known and growing challenge. Recent closures of rural obstetric units and hospitals have exacerbated concerns about access to care for millions of women of reproductive age living in rural communities. Many rural areas have a shortage of providers with training in maternity care. Long travel distances hinder access to prenatal care, delivery, and postpartum care, leading some women to temporarily relocate near an obstetrics facility or to choose to have a C-section. Some areas are looking at creating regional obstetrics hubs in existing rural hospitals.

Focus on obesity

National Grange president Chris Hamp recently highlighted the public health issue of obesity in rural America. In a letter to the House Energy and Commerce Committee Chair Cathy McMorris Rodgers (R-WA-05), Hamp pointed out the adverse impacts of obesity on Type 2 diabetes, cardiovascular disease, and other chronic conditions. Hamp urged the Chair to move the Treat and Reduce Obesity Act (TROA) through her committee and send it to the house floor for passage with broad bipartisan support. TROA would allow those aging into Medicare who are on existing obesity medications to continue to have access to them.

Granges advocate for dialysis patients

The National Grange and 21 state Granges petitioned the Centers for Medicare and Medicaid Services to leave the current policy for obtaining Phosphate Lowering Therapies (PLTs) in place. Patients with chronic kidney disease on dialysis depend upon PLTs to stabilize their phosphate levels. These need to continue to be available in pill form from the local pharmacy without having to travel to a dialysis center for injections and to continue to be paid for by Medicare Part D.

molecule research. Small molecule medications are adept at crossing the blood-brain barrier for the treatment of neurological conditions such as epilepsy, Parkinson's, Alzheimer's, depression, and other mental health conditions.

TELECOMMUNICATIONS

5G mobile wireless broadband coming

The Federal Communications Commission (FCC) is set to roll out the first phase of the 5G Fund for America. The \$9 billion effort will fund the deployment of fixed wireless voice and broadband service infrastructure to unserved rural areas. Small antennas will be placed on buildings every few blocks in cities and on utility poles and other locations in rural areas. In remote rural areas, additional technologies may be required. These funds are in addition to \$42.5 billion BEAD broadband deployment program currently being distributed to the states.

TRANSPORTATION

Keep ag supply chain open

A wide cross-section of the agricultural supply chain faces imminent and severe shipping

disruptions due to rail embargoes impacting trade with Mexico, potential labor strikes at East Coast ports, and historically low water levels on the Mississippi River. It's harvest time, and moving a large crop to world markets may be challenging. The National Grange, agriculture groups, food companies, and exporters wrote President Biden this week asking him and his administration to pursue all avenues to mitigate supply chain challenges facing U.S. agriculture.

OF INTEREST

Former senator, Ag Secretary, recognizes Grange

Mike Johanns was Nebraska's U.S. Senator from 2009- 2015 and Secretary of Agriculture from 2005-2007. His recent op-ed in Washington's Agri-Pulse newsletter profiled the National Grange's longstanding opposition to patent trolls. Patent trolls are nonpracticing entities that are shell companies that acquire patents but do not actually produce anything. Trolls then bring meritless patent infringement lawsuits against manufacturers of high-tech equipment that are vital to farmers and ranchers.

House passes oversight of foreign



land purchases

The House of Representatives passed legislation in September that would increase oversight of farmland purchases by investors from China, Russia, Iran, and North Korea. The bill, sponsored by Representative Dan Newhouse (R-04-WA), adds the Secretary of Agriculture to the Committee on Foreign Investment in the United States. The group is an interagency body tasked with screening foreign investments in U.S. companies or property for potential threats to national security. Foreign investors owned or leased 43.4 million acres, or about 3.4% of the nation's total farm, ranch, and forest land, in 2022, according to USDA. Representative Newhouse is a former National Grange Champion of Rural America recipient.

Delayed, canceled, partial, and expired food deliveries to tribal and senior USDA food assistance programs caused a stir on Capitol Hill, resulting in a major hearing before the House Agriculture and Appropriations Committees. Around 800,000 people rely on these feeding programs often because they lack access to grocery stores. It was discovered that USDA had consolidated its distribution system with only one contractor. That contractor will be called back to Capitol Hill at a later date to investigate the situation further.

Small molecule medicines for chronic diseases

The National Grange joined patient groups to call on Congress to protect small molecule medicine access and innovation and pass the EPIC Act. The EPIC Act would rectify unintended consequences of the Inflation Reduction Act that created disincentives for small




